

## Terms and Conditions

1. **Eligibility:** The Ambassador Card X Super Retail Group Promotion is open only to those who have purchased a Super Retail Group (Supercheap Auto, rebel, BCF, Macpac or Super Group) eGift Card. Entrants must be at least 18+ years old at the time of entry. The Promotion is open to the legal residents of Australia and is void where prohibited by law.
