### What is a managed fund?

*Managed fund is a 'registered managed investment scheme', which is a type of unit trust. When you invest in a managed fund, your money is pooled together with other investors. A fund manager then buys and sells assets, such as shares or bonds, on your behalf. You don't own the underlying investments, you own 'units' in the fund.*
