JOHN FALCONER - A LIFE PART II

We left John at the end of Part I having just been promoted to the rank of Inspector in the London Metropolitan Police Service in March 1960.

A POLICE INSPECTOR'S LOT IN LONDON

Starting out at Wallington, which he did not like, he was transferred to Tower Bridge, in the centre where "Plenty of criminals lived on the patch and I had many crime arrests – a few earning District Commendations".

In January 1964 he was appointed Inspector-in-Charge of the County of London Sessions where the 8 courts kept him busy. The ponderous bureaucratic system, however, prompted him to suggest a means of streamlining things which, on acceptance, earned him a Commissioner's Commendation – "For the ability and initiative in making a suggestion that an Antecedents Officer be appointed at the County of London Sessions whereby considerable police time has been saved".

After his 12 months term was completed he was transferred to branch duties at Southwark Station on district crime prevention duties etc One anecdote involves a callout by council dustmen on hearing crying from an apparently distressed cat in the bins – only to discover that it was an abandoned baby. While the mother was never found, the baby survived.

ROYALTY DUTIES

In June 1965 he was asked if he would be interested in joining the Royalty Protection unit which was going to involve considerable travel, and on gaining approval from his wife Jean, he accepted and was appointed No 2 officer for HRH Prince Philip, Duke of Edinburgh. And so began an 8 year sojourn in association with members of the Royal Family, in particular, HRH Princess Margaret.

His first travelling assignment was a rail trip to Aberdeen, thence Balmoral Castle where his duties included escorting Prince Andrew, 5yo, and Prince Edward, 1yo in looking for a combine harvester. From there he returned to London, to be based at Buckingham Palace, where he spent 10 months as Personal Police Officer to Prince Philip and in that time spending 110 days away from home, including trips to France, Switzerland, Norway and Belgium as well as Balmoral. He recounts that at the latter, while in a snow-storm, he was to meet with an Australian police officer to be in charge of security for Prince Charles while at Geelong Grammar School's Timbertops campus. On coming face to

face with the officer, they recognized that they had been together at the Haifa police station, Palestine, 18 years before. He was fortunate in getting back to London and being invited with Jean to the Buckingham Palace Staff Christmas Ball, attended by The Queen and Prince Philip, who danced the night away, talking incessantly, according to Jean. After Christmas he spent 10 days in Liechtenstein with Prince Philip and Prince Charles, the former painting and the latter skiing.

Soon after, he was flying to the West Indies to board the Royal Yacht Britannia with the Royal Couple and 47 of the household staff on a 5 weeks tour. This included a stop in Dominica where it turned out that the police chief was none other than his sergeant at the Haifa police station.

Back in London he was informed that he was to be posted to Kensington Palace as Personal Police Officer to HRH Princess Margaret, at news of which he held some apprehension, but this was soon to be allayed and he spent the next 7 very pleasant years, starting in June 1966.

NSA SECTION

As you may have noticed in newspapers, radio and TV, National Seniors Australia has been relentless in leading the charge to get deeming rates down. On Sunday, the Morrison Government cut the deeming rate. The deeming rate applied to pensioners' savings up to \$51,800 has been cut from 1.75 per cent to 1 per cent. The deeming rate for savings over \$51,800 has been cut from 3.25 per cent to 3 per cent. That means if you are a single person with a savings account containing \$100,000 the government will deem you to have earned \$1,964 in interest, instead of \$2,473 under the old rate.

In this example, the calculation is achieved by applying the 1 per cent deeming rate to all investments up to the value of \$51,800 and the rate of 3 per cent to the amount above \$51,800. This is outlined in the table below. has its hands in pensioners' pockets. "What the Government is telling pensioners is that they are earning three per cent on their savings, when most term deposits are not even returning two per cent, how is that fair?" he said.

Changes to the deeming rate can affect your assessment for the Aged Pension, government Health Care Card and other concessions. The government stated that the latest change will benefit 630,000 part-pensioners and another 350,000 people receiving other payments. While the maximum benefit to a single pensioner will be \$31 per fortnight and \$40.50 for a couple, in reality the scale of the benefit will vary, depending on personal circumstances. Any increase paid from the end of September will be back dated from 1 July 2019.

A good start, but not good enough

While National Seniors welcomed the drop in the lower rate, the higher figure remains well above the rate of return pensioners receive on their banking deposits. National Seniors Australia Chief Advocate, lan Henschke says the Morrison Government still

Here is one of the comments that were sent to us.

"I agree the recent adjustment in the deeming rates in calculating Age Pension is not good enough ... The adjustment to the deeming rates of 1 per cent and 3 per cent is ridiculous when the best you can get on Trust Accounts is 0.75 per cent and up to 2.2 per cent (principally 1.96 per cent) on Term Deposits over \$50,000."
