Dear Members,

It has been a month of memorable activities for our Branch.

The highlight for me was the talk the Hon. Fred Chaney gave on the Referendum that will be held on 14 October on establishing an Advisory Council to present the views of the indigenous people of Australia to the Parliament and Government of Australia on proposed legislation that directly effects them, so they can have a voice before, and give advice, about how their lives can be improved by future legislation.

As stated in the talk, many of our previous interventions, while well-meaning were sometimes harmful, and counter-productive, and in many cases because indigenous people had not been consulted first.

To hear before-hand from the people about whom a new law is to be made, can't be a bad thing they say it is necessary, if progress is to made and the gap they experience in health, housing and education below their fellow Australians is no longer the rule.

It will be a real test of where the majority of Australians now stand. I like the speaker am voting Yes.

## **Professor David Bohm on the Indestructibility of the Spirit**

The following was read at Quantum Physicist David Bohm's funeral service. He had written it for a memorial service of a friend:

In considering the relationship between the finite and the infinite, we are led to observe that the whole field of the finite is inherently limited, in that it has no independent existence. It has the appearance of an independent existence, but that appearance is merely the result of abstraction of our thought. We can see this dependent nature of the finite from the fact that every finite thing is "Atheism & agnosticism signify the rejection of transient.

Our ordinary view holds that the field of the finite is all that there is. But if the finite has no independent existence, it cannot be all that there is. We are in this way led to propose that the true ground of all being is the infinite, the unlimited, and that the infinite includes and contains the finite. In this view, the finite, with its transient nature, can only be understood as held suspended, as it were, beyond time and space, within the infinite.

The field of the finite is all that we can see. hear, touch, remember and describe. This field is basically that which is manifest or tangible. The essential quality of the infinite, by contrast, is its subtlety, its intangibility. This quality is conveyed in the word spirit, whose root [Ind. Eur. speis] meaning is "breath." This suggests an invisible but pervasive energy, to which the manifest world of the finite responds. This energy, or spirit, infuses all living beings, and without it any organism must fall apart into its constituent elements. That which is truly alive in the living being is this energy of spirit, and this is never born and never dies.

#### In Their Own Words

"What is needed today is a new surge that is similar to the energy generated during the Renaissance but even deeper and more extensive; the essential need is for a "loosening" of rigidly held intellectual content in the tacit infrastructure of consciousness, along with a 'melting' of the 'hardness of the heart' on the side of feeling. The 'melting" on the emotional side could perhaps be called the beginning of genuine love, while the "loosening" of thought is the beginning of awakening of creative intelligence. The two necessarily go together." — David Bohm

#### THE VOICE REFERENDUM

Fred Chaney addressed our meeting on 1 September on the subject of the Voice referendum. He introduced himself as a supporter of the Voice who regretted the politicisation of the issue which meant it was being considered as a political issue instead of whether it was good for the country. Because the debate is so highly party politicised he said he would rely on statements and facts which preceded the referendum debate when people were trying to deal with solving problems rather than gaining political advantage.

He made the point but there is no issue about recognition with both the yes and no advocates supporting recognition of First Nations people in the Constitution. The No case revolved around the idea of the Voice, that it was divisive and brought race into the Constitution. In fact race had always been in the constitution and Aboriginal and Torres Strait Islanders (ATSI) were the only group consistently legislated about.

He suggested that members could access the materials he referred to on the web stop and encouraged members to do so because they illustrate having mechanisms to listen to ATSI is not a divisive issue.

His first reference was to the actual words that are proposed to be added to the Constitution by n act called the Constitution Alteration (Aboriginal and Torres Strait Islander Voice) 2023. It provides there should be a body called the voice which may make representations to the Parliament and Executive Government on matters relating to Aboriginal and Torres Strait Islander peoples. It also gives Parliament the power to make laws with respect to the Voice including its composition functions powers and procedures.

The second reference was to the National Agreement on Closing the Gap of July 2020. This agreement was signed by three Liberal premiers 3 Labor premiers a Liberal Prime Minister and two Labor Chief Ministers of the Territories. This agreement represents what political leaders say when they are trying to solve problems rather than score political points. The agreement includes commitment by all governments to a fundamentally new way of developing and implementing policies that impact on the lives of ATSI people. It stems from "the belief that when aboriginal and Torres Strait people have a genuine say in the design and delivery of services that affect them better outcomes are achieved. Importantly it recognises that change in the way governments work is needed to close the gap. It goes on to say that all governments are now sharing decision making with ATSI people to accelerate progress in closing the gap. It says that the governments will listen to the voices and aspirations of ATSI people and change the way they work in response. Fred said you can't listen or share decision making with people you can't hear- they need a voice.

Fred said that all of this accords with his 60 years of experience and working on these issues. We need to do things differently.

The fact that this is not a party-political issue is reflected by the fact that the previous government (Treasurer Frydenberg) referred closing the gap agreement to the Productivity Commission for advice. The commission's report is available on the website of the Productivity Commission. It confirms governments are not in fact delivering on their commitments which require systemic and structural transformation of mainstream government agencies and institutions and points out the proposed voice to the Australian Parliament and government will or could have a role to play in holding governments to account for actions affecting ATSI people

and that independent mechanisms like the voice are positioned to shine a spotlight on good and bad practises and advocate for improved policies programmes and services affecting ATSI people. As the Australian newspaper editorialised this is a practical argument for the Voice.

Governments find it hard to listen and Fred talked about the difficulties of dealing with Centrelink as an example how hard it is to be heard. There was a lot of nodding at this example. Fred said that in his view the constitutional proposal did no more then put it into the constitution a signal to government that it should listen before it acted. He gave examples of his own attempts to carry messages from remote communities to the bureaucracy and the value he had gained as a Minister when the National Aboriginal Conference, an elected Aboriginal body, advised him as Minister for Aboriginal Affairs on the gap between what government was doing and reality on the ground.
