dash out the door; but maybe you've lost it or you don't have one. I can fix that by either making a no-cost paper one in a plastic holder or placing an order for a more professional one at a cost of \$8. Please let me know because it's good to recognize people by name; guessing is not a good option!

**Advocacy** Matters – The Royal Commission into Aged Care Quality and Safety is a landmark inquiry for Australian residential and in-home care. Despite ongoing reform, systematic failures leading to poor quality care for older Australians continue. Statistics show the number of serious risk notices issued to aged care providers jumped 170% in the past year and significant non-compliance leapt 292%.

National Senior's research revealed people using aged care services feared retribution if they complained. It also found that some of those who worked in the sector were so scarred by their experiences they vowed never to go into aged care themselves.

**National Seniors' contribution** – We have promoted the need for reform of aged care for many years and through our advocacy have contributed to ongoing aged care sector reforms. We have contributed to the commission's investigations through our submissions – providing an overview of important issues, recommendations and the impact of dementia, the submissions of our members and evidence provided at hearings by our CEO and Director of Research, Professor John McCallum.

**Filling the gaps** – January and November are months where we don't provide a social outing. The former because of school holidays/family gatherings and the latter due to the number of Melbourne Cup functions on offer across the community. There may be members who would appreciate some form of social activity during each of these months and the Management Committee has some suggestions in mind that we will discuss at the September Branch meeting.

**Plan to be there** - We have a speaker in September talking about WA historical events which should keep us riveted for the duration of his presentation. I look forward to seeing you at this meeting so keep safe, keep smiling and keep well.
