BRANCH NETWORK FORUM (BNF)

The BNF is a forum attended by representatives of all Perth Branches which meets every two months to exchange information on the operation of branches & to co-ordinate meetings, speakers, topics, etc.

The meeting on Monday 17th of Feb was addressed by Chris Grice, the National Brisbane head office CEO link by interactive video link, which was very informative. Chris went through the research carried out matters important to seniors and the wins that NSA has had and current issues which had been taken up with the both Federal and State Government. There are currently 71 NSA Branches in Australia with a total of approx. 256,000 members nationally.

Karen Furnivall, Community Engagement Manager had travelled from Brisbane Head office for the meeting and Ross Glossop, National Chairman of NSA, who lives in Perth, also attended. Karen provided a presentation covering threatened Branch closures with options to attempt to stop this from happening. The concept of a social group versus amalgamating with a nearby incorporated Branch was put forward for discussion as a future option for Branches facing possible closure and wind-up due to lack of Committee members able and willing to manage a Branch.

ECONOMICS - NATIONAL DEBT by President Jaseph Lieberfreund

Everyone has heard of the National Debt. It is the amount sovereign governments owe to lenders. Governments raise money in several ways to pay for expenditure. These are:

- 1. Taxes
- 2. Sale of assets
- 3. Borrowing

Governments borrow money usually by issuing bonds. A bond is a promise to re-pay a loan and carries a set rate of interest. Bonds are traded on bond markets and people buy and sell them, similar to shares. More on bonds at a later article.

What I want to focus on today is the National Debt which is a debt owed by a national government to its lenders which is measured in three ways:

- 1. The amount owing
- 2. The amount owing per capita

3. The amount owing as a percentage of GDP.

Have a look the table below. The amount of debt that nations carry is eye watering and more so because the debt eventually has to be repaid..... by our children and grand-children ! Debt is in many ways a current burden passed on to the future. In a sense, we borrow from the future to spend today. In 2023 total global public debt reached US\$ 97 Trillion. Current statistics indicate that 3.3 billion people live in countries that spend more on debt interest payments than on education and health care. (Source: United Nations Committee on Trade and Development).
