
The Christmas Lunch this year will again be held at the University Club Restaurant on Tues

BOOK REVIEW – "THE LITIGATORS" by John Grisham, published by Hodder & Stoughton, UK (2011) - 436 pages ISBN 9781444729788.

John Grisham is an American novelist, lawyer and former politician. His legal thrillers have sold over 200 million copies worldwide. He practiced criminal law for a decade, so his novels are rich in legal jargon, satirical twists in plots and memorable characters.

Many of Grisham's novels are set in the Southern States of USA, but *The Litigators* is set in Chicago. The main character is a Harvard Law Graduate who is burnt out working for a large, prestigious law firm. David meets Oscar, a former cop turned lawyer and Wally, an expert hustler and ambulance chaser. The three make up the firm *Finley & Figg* who mainly work in injury claims, quickie divorces and DUI cases.

When they decide to take on one of the biggest pharmaceutical companies in the States in a class action lawsuit over a cholesterol drug, which is causing heart problems, a David and Goliath battle begins. David is the only one with experience and finds himself facing his former powerful law firm in the federal court.

This is one of Grisham's most humorous novels. Oscar and Wally's private lives will keep the reader entertained; however the social message is delivered with brilliant comic wit.

A highly recommended, enjoyable novel.
