Online Safety Book for Grandparents and Carers.

Using computers and other internet connected devices can be a great way for kids to play, learn and socialise – but there are also risks. As a grandparent or carer, you have an important role to play in protecting the online safety of the children in your life. But knowing how to help them can be tricky, especially if you are not a tech expert. So this free book makes it easier for you.

'Online safety for grandparents and carers' covers key advice about online safety issues that can affect children and young people. It includes a range of practical tips, to help you talk about issues and manage them.

You will find information on many topics, from setting up devices safely right through to managing time online, dealing with cyberbullying and preventing unsafe contact from strangers.

There is also a section about online gaming and social media use, with a handy guide to some of the most popular sites and apps.

Recommendations from National Seniors Head Office to the Federal Government

STAMP DUTY

"Any of us thinking of downsizing are hit with the onerous burden of stamp duty. We are already suffering from minimal returns on any money we have invested. Interest is a mere pittance. The share market is suffering huge hits of late so any money in superannuation is suffering as well. What about lashing out and dropping the stamp duty for pensioners who are downsizing? This will free up a lot of the large houses with empty-nesters in them".

PRE-PAID FUNERAL SCHEMES

The government has approved a new mandatory code of practice for the prepaid funeral industry that aims to safeguard the estimated \$170 million being held to pay for future funerals. The code, which comes into effect on March 1, 2021, will ensure the funds are managed within secure investments under the name of the client until they are required. Payments received by the prepaid funeral seller must be forwarded within 16 days of receipt to specified investment managers that are restricted to life insurance companies, friendly societies, licensed trustee companies or the Public Trustee of WA.

DID YOU KNOW THIS IMPORTANT INFORMATION?

It is always a traumatic time when a family member passes away.

This website aims to make it easier for families to cope with the loss of a loved one. The one-stop online Australian Death Notification Service allows families to notify relevant organisations when someone close to them dies so their accounts can be closed or transferred. Often there are up to 40 government, private organisations and non-government organisations that need to be

notified. These notifications can be stressful and traumatic, taking up to several months and often requiring multiple physical visits with a certified copy of a death certificate.

The service validates details about the deceased against the Australian Death Check, a system that holds death registration data recorded by Birth, Deaths and Marriages Registries. The customer simply enters the details of the deceased, chooses which institutions and services they wish to notify, and adds their contact details. Then they will receive communication back on the next steps within 10 business days from the chosen service providers.

AUSTRALIAN GOVT DEPT OF HEALTH COVID NEWS. October 1st 2020

University of Oxford COVID-19 vaccine
The University of Oxford vaccine is one of the
most progressed vaccines in development
globally for Coronavirus (COVID-19). If it is
proven to be safe and effective and is
approved for use, it will be available in
Australia from January 2021, as part of the
Australian Government's COVID-19 Vaccine
and Treatment strategy

Government 's COVID-19 Vaccine and Treatment Strategy.

In Australia, the vaccine would be manufactured by Australian-headquartered multinational biopharmaceutical company CSL in partnership with the developer, international pharmaceutical company AstraZeneca. The Oxford vaccine is one of nine vaccines supported by the Coalition for Epidemic Preparedness Innovations (CEPI), a global partnership to accelerate vaccine development.

Testing Process

The Oxford vaccine has completed combined Phase 1 and 2 clinical trials, where it was tested in a small number of volunteers to show that it is safe. Larger combined Phase 2 and 3 clinical trials are now underway in the United Kingdom, United States, Brazil and South Africa.

Doses For Australia

Before the Oxford COVID-19 vaccine is approved for use in Australia it must pass the Therapeutic Goods Administration's (TGA) rigorous assessment and approval processes. This includes assessment of its safety, quality and effectiveness. The TGA is actively monitoring COVID-19 vaccine development that is occurring both in Australia and around the world.

If the Oxford vaccine is successful:

- 3.8 million doses will be delivered to Australia in January and February 2021
- 30 million doses will be manufactured in Australia between January and September 2021, in monthly batches. CSL will manufacture these doses on behalf of AstraZeneca

It is likely that the first doses will be given to vulnerable people, and front-line health care workers consistent with WHO recommendations.
