




MOVIE REVIEW 'The Duchess' by Lyn

A British movie based on the life of *Georgina, Duchess of Devonshire*. The movie commences in 1774 and follows her life from the time she marries the *Duke of Devonshire*, who at the time, was the wealthiest and most influential man in Britain. Beautifully filmed with magnificent stately homes and gardens as the back drop, gorgeous gowns and fashion. It was a time when women didn't have much of a say in the running of everything, but Georgina had more spirit and was considered quite the beauty and toast of London town, holding many a dinner party with such luminaries as King George II, George Pitt, etc. (This was during the period of the Boston Tea Party and the armed conflict between Britain and America.) Georgina's life needs to be watched to understand the circumstances of women's life during this period. She is also an ancestor of Princess Diana and I found there are some similarities by the end of the film.

Mv Trip to India by Judith Hollier

Earlier this year my sister-in-law and I travelled to India with 'Tripadeal' and were both so glad that we took that chance to visit a place not previously on our radar.

We travelled to Delhi to visit grand locations like India Gate (like Arc de Triomphe), the great Mosque and Red Fort followed by Old Delhi bazaar in a rickshaw then a bonus - Gandhi's peaceful and beautiful villa / garden where he spent his last days before assassination. One of the special places of the world.





Next was Jaipur, the pink city, where we learnt of the 1,000 year old Mughal / Muslim Empire with its breathtaking architecture and culture.



We wandered through the Maharajah's Palace with its exquisite vistas of the surrounding city and countryside through eastern arched windows and porticos. Watched the elephants marching through the magnificent courtyards.



Agra of course was to visit the Taj Mahal and it was a dreamy time for us. We had not expected the reverence of the Indian tourists who were beautifully

dressed for their outings.

Varanasi and sunrise on the Ganges River followed. The

scene of cremations held on the banks was both most reverent and business-like – the Indian people seemed to cope with spirituality and survival up close; I guess because their culture is 7000 years old, they take most things in their stride.



Lastly, we visited Darjeeling and Kalimpong in the highlands, close to Nepal and Tibet, to see Mt. Everest, tea slopes and experience amazing winding mountain roads, pretty towns and colourful houses clinging to the roadside. Staying in lovely old hill station hotels, we imagined the old colonial days here.

A 2 weeks guided tour is not of course enough to say we know the country or its people well, but it was a glimpse of life and history so different to ours.

My most memorable sight was a big plaque on an engineer regiment headquarters (the Indian Army is huge) "Powered by Intellect".

PS. This company looked after us well even though there were only 4 people on our tour and covid was affecting many arrangements. As long as we were prepared to be not too precious, we could enjoy the good food, accommodation and sights that were India.



that you may have missed Commissioners mull 'courageous' aged care reforms (29 October 2020)

124 recommendations have been presented for consideration to the commissioners. What does it all mean?



On 22 and 23 October 2020, a landmark event occurred as part of the ongoing aged care royal commission, albeit with very little fanfare.

What was presented by the Counsel Assisting over two days was a set of recommendations, which they argue should be taken up by the commissioners in their final report to the Governor-General.

National Seniors watched the announcement closely and will be working through each of the recommendations in order to put forward a response to the royal commission by the 12th November 2020. This will be the last opportunity to influence the outcomes of the royal commission before the commissioners' hand down their final report on 22 February 2021.

At the centre of the 124 recommendations is a call to shift aged care from being a system that rations aged care services, to one that provides care based on need.

Main recommendations

While you can read the detail of all the 124 recommendations <u>here</u>, we have summarised the more significant recommendations for you in this article.

At the centre of the 124 recommendations is a call to shift aged care from being a system that rations aged care services to one that provides care based on need. In doing so, Counsel Assisting tendered a cabinet note from 1997, which essentially recommended the rationing of aged care in order to constrain government spending.

The other significant recommendation is the establishment of a new independent body, the Australian Aged Care Commission, which will be responsible for the provision of aged care services to older Australians.

Recommendations include a call to:

- rewrite the Aged Care Act so there is a universal right to access high quality, safe and timely aged care services
- create a new independent Australian Aged Care Commission to manage aged care policy outside of the Department of Health and outside of government control
- create a new **Aged Care Pricing Authority** to determine appropriate funding for aged care services
- establish an independent office of the **Inspector-General of Aged Care** to monitor and report on the administration and governance of the system
- implement minimum **staffing requirements** in residential aged care and **transparency** in residential care staffing
- establish a new aged care program to combine the existing Commonwealth Home Support Program,
 Home Care Packages Program and Residential Aged Care Program with a common set of eligibility
 criteria and a single assessment process
- immediately increase home care packages to all people on the waiting list by a specified date
- remove all young people from residential aged care
- strengthen the existing **Aged Care Quality and Safety Commission** to review, improve and expand the existing quality standards
- ensure that aged care services to Aboriginal and Torres Strait Islander people are culturally respectful and safe
- develop aged care workforce strategies and strengthen the workforce council to ensure an adequate and appropriately skilled workforce is available
- increase award wages and remuneration for aged care workers to attract sufficient workers
- review aged care certificate-based courses and include dementia and palliative care requirements for all staff
- create a national registration scheme and a mandatory minimum qualification for all personal care workers
- promote smaller residential care models through a capital grants program for 'small home' accommodation models
- ensure people with disability over 65 not covered by the NDIS receive aged care services on par with those provided through the NDIS
- establish a **Senior Dental Benefits Scheme** for those in residential care or those who live in the community who have the pension or the Commonwealth Seniors Health Card
- immediately increase the **Basic Daily Fee** by \$10 per person per day and continue the increase in the **Viability Supplement** of 30% for services in **regional**, **rural and remote areas**
- remove co-contributions for care services in the home and in residential care but include nominal copayments for domestic assistance associated with home care
- recalibrate fees for living costs in residential care so that the means tested fee is zero for those on a
 full pension rising progressively so that non-pensioners pay the full costs of living
- establish stricter prudential standards, including liquidity, capital adequacy and continuous disclosure requirements; as well as more stringent financial reporting
- introduce **civil penalties** for failure to provide high quality and safe care, including sanctions for directors and/or other personnel and the right of compensation.
- strengthen the **powers of the quality and safety commission** to investigate complaints, including the power to enter premises, compel the production of documentation and question staff
- improve **complaints management** processes
- introduce a star rating system based on measurable and comparable quality indicators

National Seniors will publish its response to the recommendations on its website when this is submitted to the royal commission on the 12 November 2020 and will provide a link to this submission in the Connect enewsletter

Wealth no Guarantee of a Comfortable Retirement

(29 October 2020) Latest Finance

Financially comfortable makes for comfortable lifestyle in retirement, right? Not necessarily, according to new research by National Seniors and Challenger Limited

In a new report, Retirement Comfort – Personalised versus Standard plans, National Seniors and Challenger have uncovered some interesting attitudes amongst seniors and comfortable lifestyle spending.

It found that being wealthy was not necessarily a guarantee of living a comfortable lifestyle.

Conversely, the joint research also found that not everyone on the aged pension found they were 'constrained' in their lifestyle spending.

"Being wealthy certainly means people can spend more on their lifestyle, but our research shows that personal priorities and preferences are critical in defining retirement comfort," National Seniors CEO, Professor John McCallum said.

The report surveyed National Seniors members on spending attitudes on a range of lifestyle categories including:

- eating out
- holidays
- energy bills
- quality products
- home renovations
- household items and appliances
- phone and internet connection
- quality clothes.

- Those aged 70 79
- Those aged 80 +

Interestingly, the category all three age groups felt the least comfortable spending was eating out.





While taking holidays ranked high in spending comfort among the 60 – 69 and 70 -79 age groups, less so for those aged 80 plus.


Respondents were divided into three age groups:

- Those aged 60 69
- Those aged 70 79
- Those aged 80 +

Interestingly, the category all three age groups felt the least comfortable spending was eating out.

As well as wealth, alleviating people's worry about outliving savings was also very important to their spending decisions. Even if you are wealthy, being worried about having enough to last will affect your spending patterns and financial comfort.

Professor McCallum emphasized that COVID-19 has upended the future for many retirees who are now experiencing serious financial hardship and distress.

"Our planning of a comfortable retirement lifestyle needs to be reinvented and tailor-made," he said. "This is especially important now that information and advice are becoming increasingly digitalised with the strong temptation to standardise it!"

"Dealing with these issues is a priority to minimise retirees stress. We need to ensure planning for retirement comfort is focused on personally relevant assumptions about future needs".
